There are several researchers that state Catherine Wilson Married Andrew McMillan. One such reference is "You Take It From Here" by Marshall A. Wilson. I have not found any marriage certificates. I am trying to find out who Andrew McMillan's parents are. Both he and Catherine Died before 1850. They lived in Knox County. There are several McMillan's living in the area as well, but no idea if they were of any relation. They eventually moved to Clark County Illinois where Andrew Wilson McMillan was born; and he states so on ...several census records that he was born in Indiana/Illinois. Andrew was orphaned and raised by his grandfather Isaac Wilson and he can also be found on the 1850 census, Knox County, under Isaac Wilson's house hold. Thanks! Erica Trisch
