James Henry Gault

I am researching my genealogy. James Henry Gault, my grandfather, moved to Anderson County from Strawberry Plains, TN in 1914. He purchased 200+ acres on Edgemore Rd. (now Old Edgemore) with a log cabin on it, rumored to be the first building in Anderson County, built by a Mr. Frost, and used as a Stage Coach stop. I am hoping to locate information about the fire that burned the original log cabin between 1938 - 1940. At the time of the fire, the cabin was owned by Azalea Gault Smith and Jack Smith. Azalea, my aunt, was the youngest child of James Henry and Cora Azalea LaRue Gault. I was there when the fire started, however, the only memory I have of it is seeing the flames from the car window as Aunt Azalea drove past the house down the drive way honking the horn to waken the other relatives living nearby. I will appreciate any information about the fire and property, or where I could search for the information. I am the daughter of Thomas Albert Allen, Jr and Lois Gault. We will be offering electronic versions of the Pellissippian this year. If you have interest in receiving the Pellissippian as a pdf file instead of a printed copy, please contact us and we can put you on the distribution list.

For members who continue to receive printed copies of the Pellissippian, we need your help to maintain the society's bulk mail status. The US Postal Service requires us to verify recipients' zip codes once a year. If your postal address has changed in any way, please let us know. An incorrect address means that you'll miss receiving your Journal.

Remember to send us an update if you change your USPS mail address or email address. If the address or zip code isn't absolutely correct, we may get their journals back as "Undeliverable as addressed...Return to Sender...Postage Due \$1.65." Resending as first class mail will cost an additional \$1.82.

Even if the recipient moves to another apartment in the same building, the journal is returned to us, because the address is viewed by the USPS as incorrect.
