For members who continue to receive printed copies of the Pellissippiian, we need your help to maintain the society's bulk mail status. The US Postal Service requires us to verify recipients' zip codes once a year. If your postal address has changed in any way, please let us know. An incorrect address means that you'll miss receiving your Journal.

Remember to send us an update if you change your USPS mail address or email address. If the address or zip code isn't absolutely correct, we may get their journals back as "Undeliverable as addressed...Return to Sender...Postage Due \$1.65." Resending as first class mail will cost an additional \$1.82.

Even if the recipient moves to another apartment in the same building, the journal is returned to us, because the address is viewed by the USPS as incorrect.
